

RESTRICTIONS AND REQUIREMENTS

COPYRIGHT DISCLAIMER:

The Evergreen Aviation Museum (The Museum) obtains its photographs from many sources and uses them primarily for research and educational purposes. Certain works may be protected by copyright or trademark. The Museum will grant permission for use only to the extent of its ownership of the rights relating to your particular request. **The responsibility for ascertaining whether any such rights exist, and for obtaining all necessary permissions remains with you, the applicant.**

The Museum retains the sole copyright for its holdings and all images depicting its holdings. Photographic images that are in the care of, or are the property of The Museum, or photographs, photocopies or artistic renderings of collection items that are in the care of, or are the property of The Museum, shall not be reproduced, resold or commercially used without the specific written permission of The Museum.

The Copyright Law of the United States of America (Title 17, U.S. Code) governs the making of photocopies or other reproductions of copyrighted material. Certain conditions specified in the law authorize libraries and archives to furnish a photocopy or other reproduction. One of these specified conditions is that the photocopy or reproduction is not to be "used for any purpose other than private study, scholarship, or research".

PERMISSIONS:

The Museum issues all permissions for ONE TIME USE in one publication, one edition and one language. An authorized staff member of The Museum must grant approval for an item's reproduction in writing. Subsequent use of these photographs is restricted and requires additional permission authorization. The reproductions and their contents will not be further reproduced or published in part or in full, sold or given to another person, or made available to another person or institution without written approval from The Museum. Downloading an image from the website in no way transfers either copyright or property right and does not constitute permission to publish or display in excess of fair use.

PAYMENT AND FEES:

Payment in full is required, and is to accompany the written request for services. Permission to reproduce Museum materials is contingent upon payment of fees. Please make checks out to "Evergreen Aviation Museum" and note "For Photo-Reproduction". The Museum assumes no responsibility for any royalties or fees claimed by the artist or photographer, or on his or her behalf.

CREDIT:

Full credit to The Evergreen Aviation Museum, McMinnville, Oregon, must appear in immediate proximity to the reproduction or in the section within the publication devoted to acknowledgements. In the case of motion picture publications, visual credit must appear at the beginning or at the end.

RESTRICTIONS and LIMITATIONS:

The applicant will not use these photographs to show or imply Museum endorsement of any commercial product or enterprise, or to indicate that The Museum concurs with the opinions expressed in, or confirms the accuracy of any text with these photographs. The Museum may refuse permission to reproduce images if the reproduction does not meet Museum standards or if their use would be detrimental to the collection or to the reputation of The Museum. If so requested, the applicant must provide a proof for Museum approval before reproduction of an image.

COPY OF PUBLICATION:

As part of the agreement to grant reproduction permission, The Museum requires that, immediately upon publication, two copies of the publication in which The Museum photographs appear be furnished at no cost to The Museum for use in our library and archive files. No new photo orders or permission requests submitted by the organization, production company or distributor will be processed if the copies have not been received by The Museum within three months of the stated release date.
